Trading in securities of these 48 companies will be suspended w.e.f. Wednesday, July 11, 2012 (being 15 trading days from issue of notice); on account of non-compliance with the provisions of the Listing Agreement.

- (i) In case, the company complies (to the satisfaction of the Exchange) with all the provisions of the Listing Agreement on or before <u>Tuesday</u>, <u>July 3</u>, <u>2012</u>; trading in securities of the company will be suspended for Five Trading Days i.e. **upto Tuesday**, <u>July 17</u>, <u>2012</u>.
- (ii) However, in case the company fails to comply with the provisions of the Listing Agreement, to the satisfaction of the Exchange on or before Tues<u>day</u>, <u>July 3</u>, <u>2012</u>; the**suspension will continue** till such time the Company complies with the procedure prescribed for revoking suspension in a scrip and the company complies with all extant norms for revocation of suspension laid out by the Exchange.

It may be noted that suspension of trading in securities of a company will be revoked only if the company has complied with all the provisions of the Listing Agreement upto the latest quarter for which the compliances are required.
